Objectives

This policy has been drafted keeping in mind the following objectives:

- This policy aims at strengthening the leadership by providing a simple and efficient system of governance within the institution in the area of E-governance.
- To provide online service facilities to all the stakeholders.
- To provide easy and quick access to information for all the stakeholders and promote transparency and accountability in all the functions of the Institution.
- To promote and move towards a paperless environment in the college.
- This will optimize the administration's performance in decision-making.
- This will enhance the overall efficiency of the faculties as well as the administration and thus improve the quality of the work culture in the Institution.
- The Institute shall comply with the e-governance norms and policies of Govt. of India and Govt. of Madhya Pradesh.

Policy & Areas of Implementation

The IT Centre, Holkar Science (Model, Autonomous) College, Indore shall act as an implementing Agency for all e-Governance implementation in the institution. IT Centre shall coordinate the overall implementation of the policy.

The Institution has implemented E-Governance in the following areas, which is regularly upgraded:

Website

- The College strives to showcase its vibrant self and activeness through its website.
- The website of an institution is its face; therefore, it should showcase its vibrant self and activeness through its website.

- All the activities, important notices, courses offered, etc should be timely updated.
- Training should be given to the administrative and teaching staff to make important updates on the website.
- A Website Committee should be in place to monitor the input Institution's website.
- The IT departments shall look after the process of updating, maintaining, and working on the website on a regular basis.
- As and when required, the website should be upgraded.
- All the important notifications have to go live on the website as and when they are released.

General Administration

- The Institution is governed by the Department of Higher Education, Govt. of Madhya Pradesh, and all its communication with the higher authorities is governed through the Official website and email.
- The Administration communicates with teaching and non-teaching staff through email and LMS Platform.
- All the important administrative information including notices is regularly published on the website.
- Biometric attendance for all staff members.
- Campus with wi-fi internet facility.
- To progress towards Paperless Culture, institution promotes usage of Google sheet / Google forms / Google Docs for data collection from Various Departments, to prepare notices and activity reports and prepare Feedback forms and get online feedback from students, teachers, alumni, and employers.
- The college campus is equipped with CCTV cameras installed at various places for e-surveillance.
- Additionally, institutionally designed LMS and WhatsApp Groups are used to disseminate general and specific information to students and are also used for Mentor-mentee interaction.

Student Admission

- The institution follows the centralized admission procedure as per the guidelines of the Online admission procedure of the Department of Higher Education, Govt. of Madhya Pradesh since 2012.
- The admission portal takes care of all the processes from initial data filling by the institution, from filling by students, verification of the documents, generation of the admission list, payment of Admission fees, and generation of receipt and admission letter, all are through e-mode.

Examination Management

- Examination Management is efficiently handled through Examination Management System.
- Filling examination forms, obtaining admit cards, uploading of mark sheets, etc. everything is done through e-mode.
- The Examination Department monitors the complete process of examination and its management under the guidance of the examination controller of the institution.

Library Management

- Keeping in pace with the modern internet age, the library is also modernized by automating it with ILMS, SOUL 2.0 Software.
- E-resources such as NLIST-INFLIBNET and DELNET should be regularly procured for increasing access to faculty, researchers, and students.
- Appropriate training for the staff and students should be provided for the use of e-learning of these e-resources.
- The institution must strive to provide remote-access facilities to all its stakeholders.

Financial Management

- The Accounts Section maintains its account on Tally.
- Latest versions of the software to be procured and used by the institution to maintain financial records effectively and efficiently.
- Profit and loss, Balance Sheets are generated through this software only. All the analysis reports are also being generated through Tally.
- Proper security measures should be taken for maintaining the confidentiality of the transactions.
- Updating of the existing software and training of upgraded software to the existing staff must be done regularly.
- The Institution also uses multiple software like Integrated Financial Management System (IFMS) and Public Financial Management System (PFMS) for the management of the funds received from the Government for disbursement of salary to respective bank accounts, generating salary slips, TDS, Provident Fund, Allowances, etc.
- All Payments should be done and received through online modes such as NEFT, RTGS, Bank Transfers, etc.
